- e. Desired features include: Lap Lanes, Diving Boards, Shade Areas, a Tot Area, non-Aquatic amenities (Tennis?)
- f. Create a “Destination”, attracting outside interest.
- g. Conklin has 8 Lanes for 90 swimmers; Glenside has 6 lanes for 90 Swimmers
- h. Upgraded Site Lighting desired for Swim-Meets
- i. A PA / Sound-system is desired for communication throughout the facilities
- j. Explore option of (1) pool vs (2) pools, based on cost
- k. Neighborhood Pools vs Regional
- l. SprayGround feature – what are staffing requirements? Will a Safety Monitor be needed?
- m. Steering Committee thoughts from the last meeting:
  1. Enhance & Continue Lesson programs
  2. Lap Swimming is important. Need dedicated lanes always available for adults
  3. Would like more diverse programming & amenities, to draw more users
